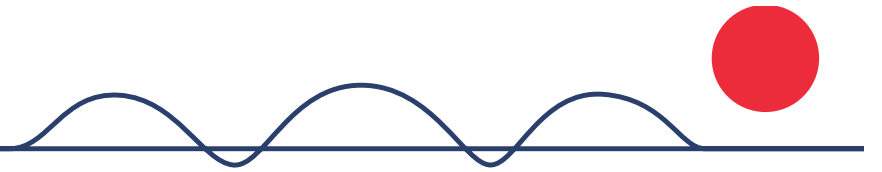

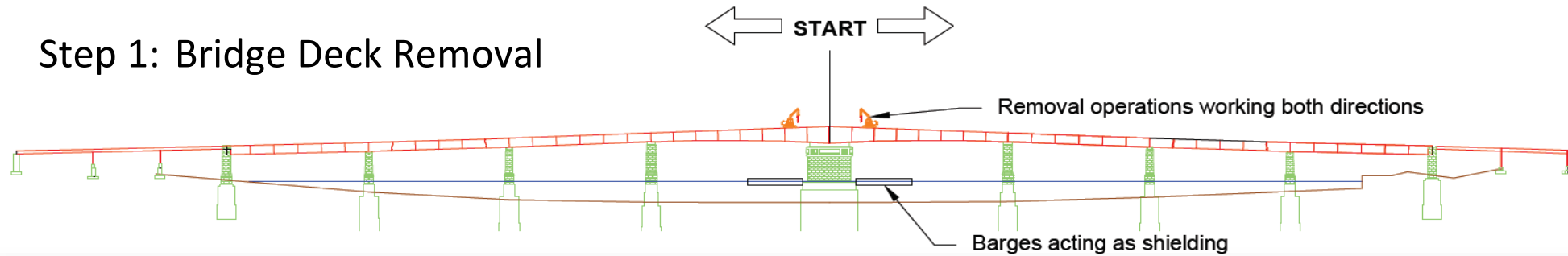

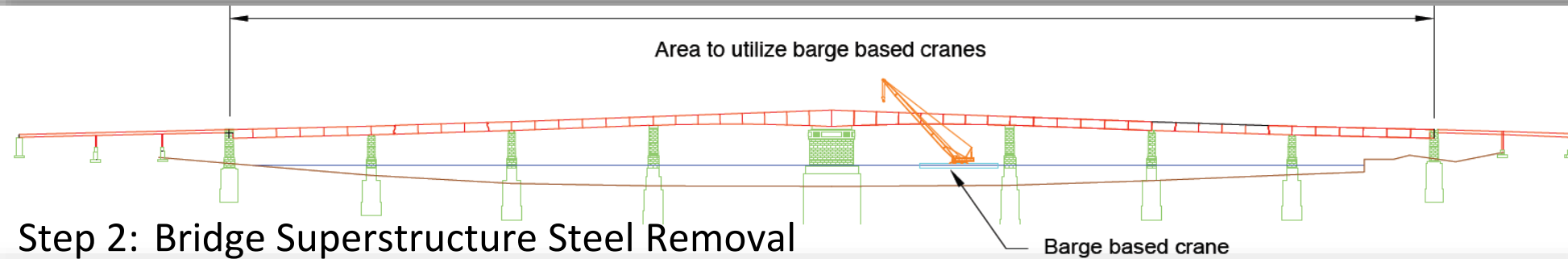

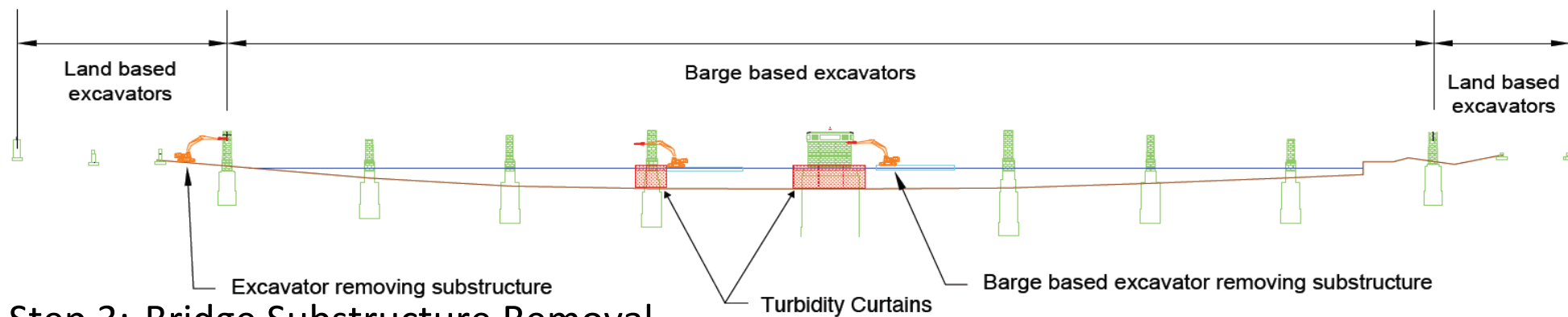

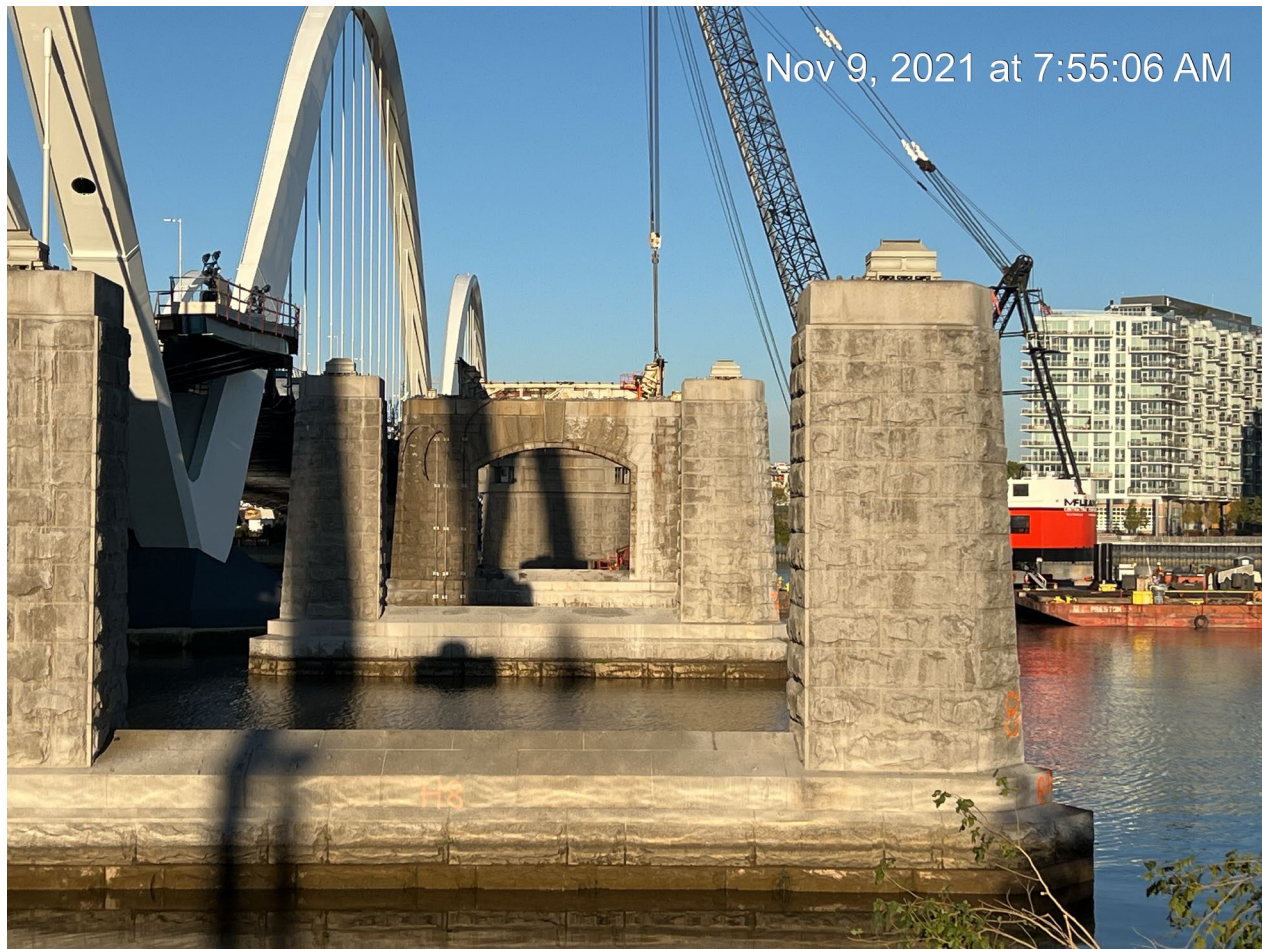

EAST OVAL AND ESPLANADE



The East Esplanade provides a direct connection to the Anacostia River and Riverwalk from the Frederick Douglass Memorial Bridge and the East Oval. The broad expanse of the Esplanade allows for a series of terraced seating walls to serve as an amphitheater for concerts and other shows. The Esplanade also includes an open lawn area that offers further flexibility with respect to activities and future programming.

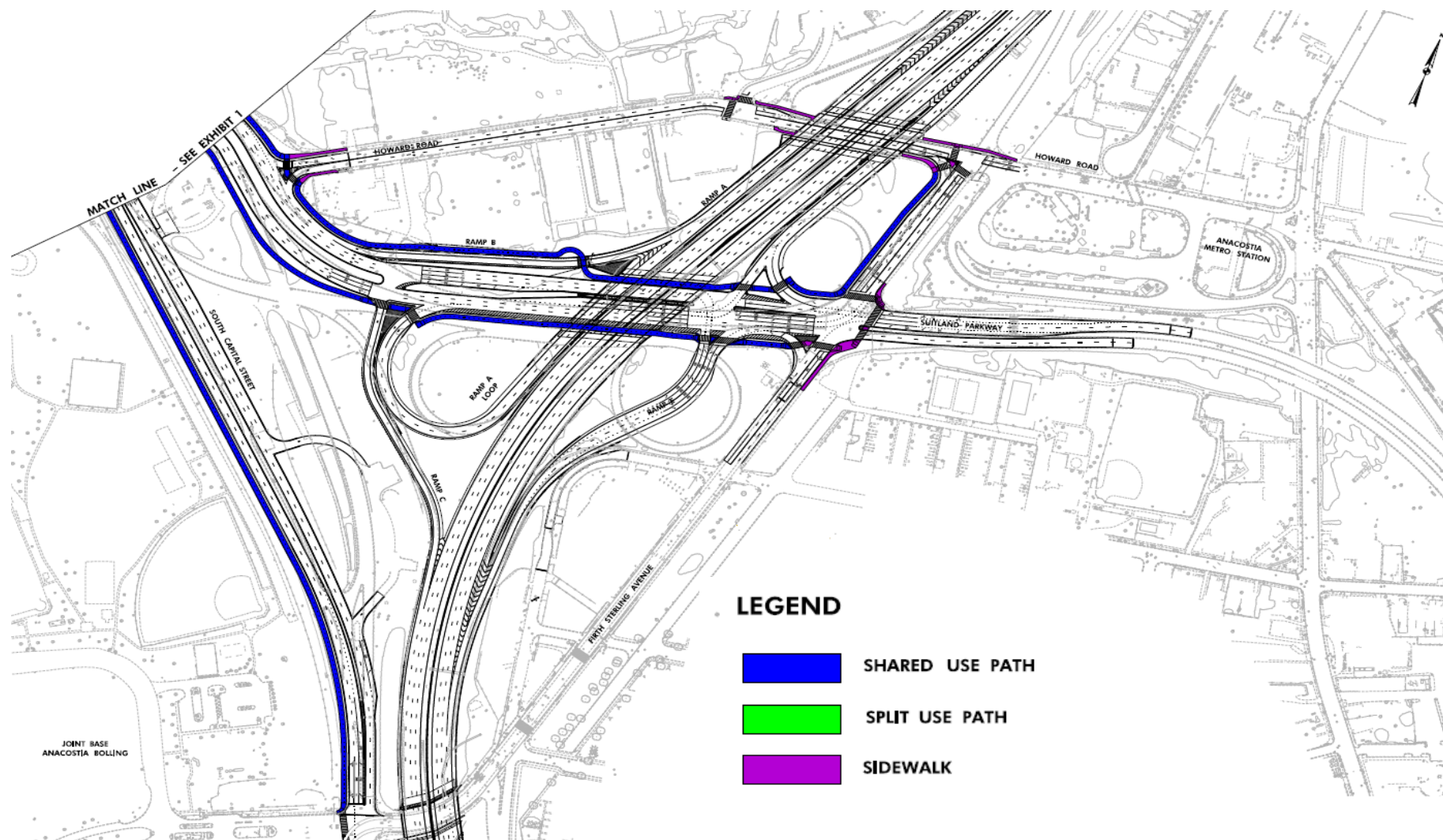

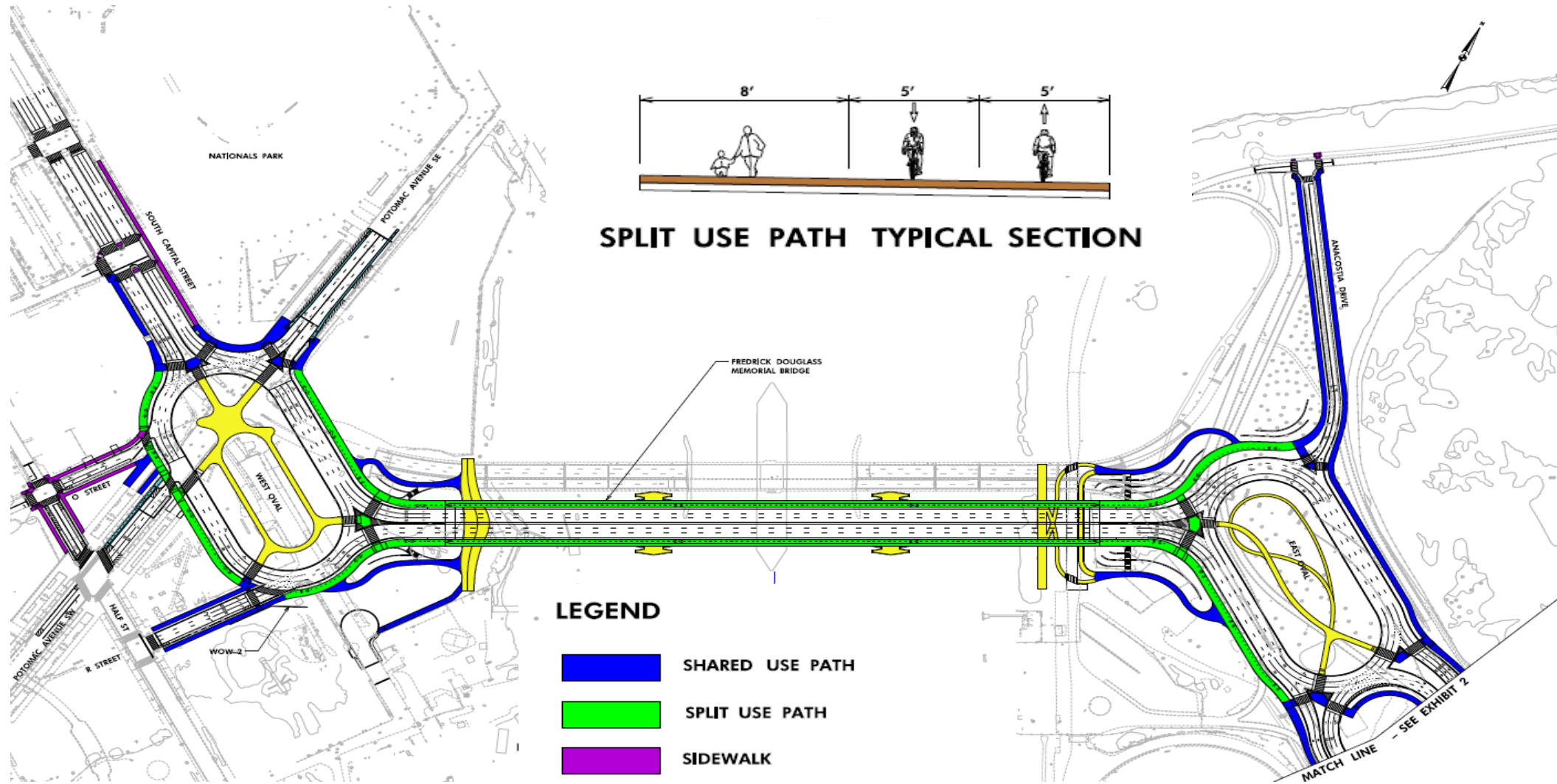

- Total Project Costs
 - Phase 1 - \$441M
- DBE Goals:
 - Design Phase - 13.05 % (\$11.7M)
 - Awarded 100% (\$11.7M)
 - Construction Phase - 21.77% (\$76.9M)
 - Awarded 101% (\$77.8M)

 - 51% of new project-related jobs performed by DC residents
- All hiring governed by Project Labor Agreement (PLA)
 - CHOICE manages all hiring under the PLA
- Total Number New Hires = 1046
 - Local Hires = 212
 - Percentage of New Hires DC Residents = 20.27%
- On-the-Job Training Program
 - Total Number Graduates= 29
 - Total Number Currently Enrolled = 12

- 2021 Cohort 3 – completion ceremony November 8,



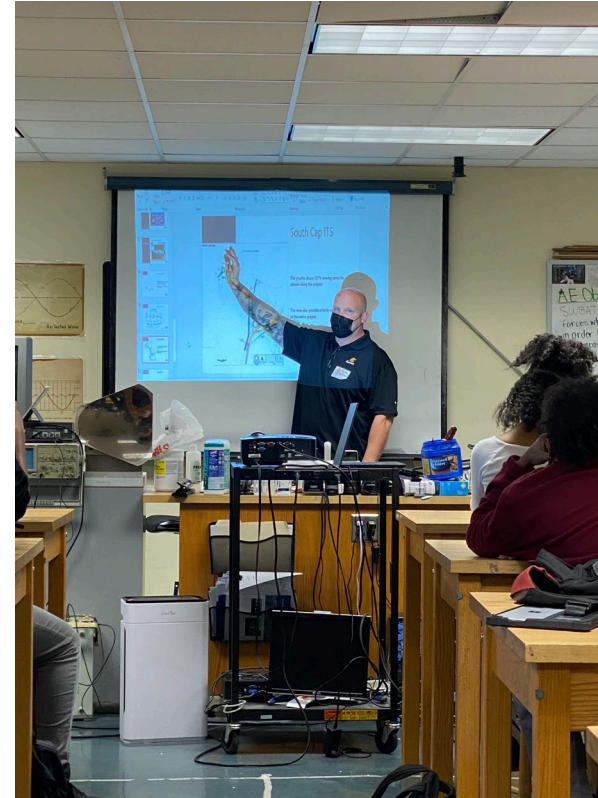
STRIVE

Program Overview

- The DDOT South Capitol Street Corridor Project Team and its contractor South Capitol Bridgebuilders partnering to mentor the next generation of civil engineering professionals.
